

MERDEKA PHOTOGRAPHY COMPETITION 2017 TERMS AND CONDITIONS

BASIC TERMS

1. Organiser

MTrustee Bhd acting in its capacity as trustee for IGB Real Estate Investment Trust ("IGB REIT"), owner of Mid Valley Megamall and Nikon (Malaysia) Sdn Bhd

2. Name of Competition

Merdeka Photography Competition 2017 ("Competition")

3. Theme of Competition

"BUNGA RAYA" (national flower of Malaysia) is the central theme of this Competition; for the public to express through photographs/images captured ("Images"). Photograph(s) submitted must include the item in real flower form and not a representation, drawing or other form.

4. Criteria for Participants

The Competition is open to all Malaysians who are:-
Adult Category – 18 years and above as at 1st Jan 2017
Student Category – 7 to 17 years old as at 1st Jan 2017

5. Competition Period

The Competition shall be held from 12:00am on 1 June 2017 to 12:59pm on 15 July 2017 or such other time that the Organiser shall decide from time to time.

The Organiser reserves the right to vary, postpone or re-schedule the Competition Period or any dates thereof at its sole discretion.

6. Language of Competition

The Competition will be organized by the Organiser in the English language.

7. Entry Procedure

Participants must take a photograph relevant to the Theme and submit via email the Images to the Organiser to Mid Valley Megamall's website (www.midvalley.com.my) or email to photocontest@midvalleycity.com.

In addition to the above, all shortlisted participants are also required to submit his/her Full Name (as in new I/C or Passport), new I/C/Passport No, postal address, and telephone/mobile number within the stipulated date stated in the Organiser's email, notifying the said participant being shortlisted.

A Participant may submit multiple entries. However, only ONE (1) prize will be given to the said Participant. Any additional prizes (if declared) will be automatically void.

8. Entry Deadline

Entries must be received by the Organiser on or before 12:59pm on 15 July 2017. Entries received after the stipulated time will be disqualified from the Competition.

9. Submission Format of Images

Images captured by cameras can be of any format, using film or digital, in color or monochrome (black and white) excluding images captured with mobile phone and/or Personal Digital Assistant. Images must be taken ONLY in or of Malaysia and have not be submitted in any contest or event and regardless whether any prizes was given thereto.

Any form of digital imaging (including sepia, monochrome) or image manipulations (including HDR and IR) is allowed. All shortlisted participants are required to submit to the Organiser upon notice thereto, the digital file of high res images that was posted, in the ORIGINAL FULL RESOLUTION with full EXIF data with file size of 5MB and above in a CD for verification purposes failing which the entry will be automatically disqualified from final judging. The Organizers may also at its discretion, request submission of a RAW file image.

All entries and/or Images must be the original creation of the Participants, unless written authorization from the creator and/or proprietary owner is provided at the time of verification to avoid a disqualification.

Participant shall not submit any pornographic, obscene, criminal or adult themes, links, cultural or race discrimination or images that in the Organiser's sole opinion is/are offensive.
