1.	Organiser	AmTrustee Bhd acting in its capacity as trustee for IGB Real Estate Investment Trust (“IGB REIT”), owner of, inter alia, Mid Valley Megamall
2.	Name of Contest	Hi-5 MEET AND GREET CONTEST 2015 (“Contest”)
3. 6.	Language of Contest	The Contest will be in the English language.
